9.3 Eightmile Valley Project - Greg Dills. With Larry Ray he participated in a conference call with BLM staff about the remaining deliverables (As Built Drawings, Operations and Maintenance Plan, and Draft Final Report) for the 319(h) contract. All work must be completed by March 31, 2021, and no funds may be invoiced after April 30, 2021

9.4 Goats Rue Project - Greg Dills: the MOU with the county has been approved by County Counsel and should be agendized for LCRCB Board approval in January

9.5 CalTrans Revegetation Projects - Greg Dills. the trees are dormant and the watering system put up for the season. The county wants a functional well by the end of January

### 9.7 President/Director Reports

- Lyons: working on CWPP: a recent CARB report says prehistoric fire frequency was greater than today. The Blue Ribbon Committee meets tomorrow. One of the properties the county needs to acquire for the Middle Creek wetlands restoration project has recently gone into escrow and another is about to do so.
- Velasquez: Paradigm Properties, the broker charged with facilitating the Middle Creek property acquisitions, started out working on 8 properties (nearly two years ago), not an impressive pace of work. They recently brought another company in to assist. In the intervening time at least one of the target properties has been sold to the Clear Lake Duck Club.

- Brandon: USFW recently made a determination that the hitch are not eligible for listing under the Endangered Species Act, partly based on misleading information and assumptions. Center for Biological Diversity may take legal action, and the new administration may reverse the position even without litigation.
- Bridges: will attend the upcoming meeting of the North Coast Collaboration group. He talked to CalFire who said they have been unable to collect locally-appropriate conifer seeds, partly because the 2018 Mendocino Complex fire destroyed so many of the source trees
