- 8.1 Recruiting of Directors and Associate Directors: nothing new
- 8.2 Meisenbach Scholarship: Lyons sent out application forms and will follow up closer to graduation
- 8.3 Invasive Weed Tour. Brandon: event has been scheduled for May 13 at 9AM, at Anderson Marsh
- 8.4 Field Days in the Creek. Lincoln: event has been tentatively set for May 20.
- 8.5 Kids in the Creek. Velasquez: event will be held on March 19, with about 50 kids expected. Lyons, Lincoln and Shoup are available to assist.
- 8.6 Trout in the Classroom: Blyleven: CDFW recruited an additional teacher who was trained in the Sonoma program and already had a tank. We are back up to five teachers: one each at Lucerne, Upper Lake, and Clearlake and two at Coyote Valley. He went to Upper Lake Middle School yesterday to set up the tank and will pick up eggs at Yountville and distribute them on February 27. Two classes will disperse into Blue Lakes and three into Putah.

9.1 Lake County Fire Safe Council Report - Laurie Hutchison. Working with North Coast Opportunities (NCO) on different local events and opportunities; preparing for the upcoming Natural Resources Day in Lake Co; In talks with event planners for "Protecting Your City From Wildfire" Summit re: a scholarship for attendance/travel and considering being a member on one of their panels for the event. Coordinated outreach efforts with local agencies for events- including promoting local events via social

media, including Emergency Preparedness for Seniors (Lucerne) and upcoming events on Cobb; Looking into grant opportunities for more local event funding.

Outreach to public regarding PSPS event preparation, during outages and updates via social media. Discussing the next Lake Co Fuel Reduction/Post Fire Funding Opportunity meeting with USFS. Met with local Firewise Community members re: updates, ideas and community event planning. Participated in monthly agency meetings. Discussing grants and projects with various agencies. Assisting with creating new Firewise Communities.

9.2 NRCS Report - Korinn Woodard. Last week Lucas from Napa RCD reached out re 1 year grant; new applications are due this Friday. This grant supports Tom Bendure's work. Directors need to keep track of their volunteer hours and send them to her for match. All expenditures on the CalTrans project will count towards match as well as the reforestation project.

Memorandum of Agreement between NRCS and LCRCD: our existing sharing agreement with NRCS has to be updated to conform to new standardized language.

- 9.3 Eightmile Valley Project Greg Dills. BLM visited the project in January and was pleased with the project through the recent rain. There are several areas to be addressed in the spring, but overall the project is functioning as designed.
- 9.4 Goats Rue Project Greg Dills: no field work
- 9.5 CalTrans Revegetation Projects Greg Dills. Implementation continues; getting wood chips has been a problem. The contract with T & T Tree Care will require modification; it was written with the incorrect prevailing wage classification and the correct rate is higher than the one used.

- 9.6 Reforestation Project. Brandon: 18,000 CalForest seedlings were delivered to the warehouse on February 6, under Lyons' supervision, and by now almost all of them have been picked up. The additional three boxes of DF we are getting from Mendocino RCD still haven't arrived and aren't expected much before the end of the month.
- 9.7 Native Plant Project. Velasquez: Nothing new since last month. We will sell plants at the Big Valley Grange sale on May 3, and in collaboration with the Master Gardeners at the Ag Center on May 16; it might be necessary to arrange plant pick up for one or both events, depending on Karen Sullivan's schedule.
- 9.8 President/Director Reports
 - Brandon: the hitch run could start any time; there's water in the creeks despite the lack of rain recently. Upper Lake USFS District Ranger Frank Aebly will give a presentation on Ranch Fire recovery at the Sierra Club meeting at New Paradigm College on March 26.
 - Bridges: will attend a Forest Service meeting in Williams on February 13 to get a Ranch fire recovery update.
 - Velasquez: the LC Land Trust is still waiting to close escrow on the Wright property.

10.1 Bookkeeping services: Marlene Wentz is willing to continue until April 15 but will bill for 19 hours @\$55/hour for March and April, up from the current charge of \$540. Tracy Klein has expressed willingness to take over after tax season ends; we need to get a contract from her in time for approval at the April 14 meeting, or if that's not possible hold a special meeting later in the month.
