9. REPORTS/UPDATES

9.1 Lake County Fire Safe Council Report - Laurie Hutchison. Blue Lakes is interested in starting a Firewise Community. She has been working with Hospice on outreach to 500 homebound seniors, has 1000 emergency evacuation handouts ready to distribute at the Lake County Fair, and additional materials aimed at children. Supervisor Jessica Pyska says the Cannabis Alliance wants to help, possibly by providing a trailer for outreach and stocked with tools for mitigation projects. 9.2 NRCS Report - Korinn Woodard had technical problems and had to drop off the call.

- 9.3 Civic Spark Fellow report Laurel Bard. Her fellowship terminates at the end of July but she is going to continue the work as a CLERC employee. Firesafe project priorities are being adjusted to concentrate on communities: sharing and collaboration are crucial to effectiveness. Strong new mapping software is now available, and the maps posted to CLERC's website.
- 9.4 Eightmile Valley Project Greg Dills. Molly Nilsson is no longer with BLM. Larry Ray is caring for the revegetation materials until it's time to plant, hopefully in the fall.
- 9.5 Goats Rue Project Greg Dills: Ag. Dept., BLM, and RCD staff (seven people total) hand pulled Goat's rue on June 14 & 15 -- perfect timing and weather conditiions. Down stream and the seed source still need treatment. BLM is still waiting confirmation of the herbicide use permit. Future work will be conducted under the county's new CDFA grant.

- 9.6 CalTrans Revegetation Projects Greg Dills: The well and transmission line to the holding tanks are functioning. The tanks are being filled by a hand valve at this time, but it is working well. Float valves will be installed in the tanks at a later date.
- 9.7 Healthy Soils Program Greg Dills: MCRCD submitted a CDAF application, waiting for award notification in July.
- 9.8 Lake County Land Trust Wright Project Velasquez: 40 Foothill College students directed by Doug Prather and assisted by John Parker did an archeological survey on July 9. Dept of Water Resources did water quality study; Land Trust is figuring out what trails, signage, benches etc. are needed, with dedicated funding to support this work
- 9.9 President/Director Reports
- Lyons: attending Regional Forest and Fire Capacity Group, with Dept of Conservation funding. North Coast Coalition of RCDs hired Julia Sullivan to assist with grant opportunities, and came to an agreement with CalFire and CLERC to collaborate on planning, CEQA work and technical support, all supported by a California Firesafe grant for \$175,000. CARCD has set up a revolving fund to assist RCDs with cash flow problems. Middle Creek project: two properties are in escrow and another sale has been completed. The county committee is setting up a meeting with Cong Garamendi's staff, and Assemblymember Aguiar-Curry is trying to get the state grant for property purchases extended. Blue Ribbon committee now has money for the projects that were delayed last year.
- Brandon: along with other regional environmentalists met with Senator Alex Padilla's field aide Roberto Rizo on July 8 and took the opportunity to brief him on the Middle Creek project and invite him for a site tour.

Lincoln: he and Krag are continuing to attend soil health meetings
